Sub: Sanction of subsidy to different O.H.R.E Institutions for "Sital Sasthi Festival" for the Year 2018-19.

Sir,

I am directed to convey the sanction of Governor to a non-recurring grant of Rs.64,15,000/- (Rupees Sixty Four Lakh Fifteen Thousand) only for payment to the O.H.R.E Institutions as per the list enclosed and the amount as noted against each to meet the expenses for the observance of "Sital Sasthi Festival" for the Year 2018-19 with the following terms and conditions.

1. The amount of Grants released should be drawn and utilized for the purpose for which it was sanctioned. The grantee Institution shall ensure submission of utilization certificate in the prescribed format as per OGFR Form No.7(A).
2. The Grantee Organisation should maintain a register in Form No. OGFR-30A with regard to permanent and Semi-permanent assets acquired wholly or substantially within the grant and a copy thereof should be furnished to the Sanctioning Authority, as required under Rule 171 (5) (i) of O.G.F.R.
3. The assets so acquired should not be transferred/sold/replaced or disposed of in any manner without prior approval of the Sanctioning Authority.
4. The Grantee Organisation should also maintain a register in Form No.33 as per rule provided in Appendix-10 of O.G.F.R. and Countersigning Authority should also maintain a register in Form No.32.
5. The amount sanctioned/released above is subject to final adjustment on the basis of the audited figures of actual expenditure incurred exclusively on the items for which it is sanctioned.
6. The G.I.A. is subject to audit by the examiner of L.F.A, Odisha and open to test check audit by the A.G., Odisha, Bhubaneswar/Administrative Department at their discretion.

The Commissioner of Endowments, Odisha, Bhubaneswar is authorized to draw the amount and disburse the same to the concerned institutions after receipt of the U.C. of previous grants, if any.

The charge is debitable to Demand No.4-2250-Other Social Services(EOM)-103- Upkeep of Shrines Temples etc.-0872-Management of Debottar Institutions -41048-Grants-918-Grant-in-aid-General(Non-salary) for the financial year 2018-19.






