Information regarding re-engagement of retired officer/employees in different categories in the O/o the Commissioner of Endowments, Odisha, Bhubaneswar and three of its zone offices at Cuttack, Berhampur and Sambalpur.

1. <u>33 Numbers of retired Officer/ employees in different categories proposed to be re-engaged in</u> service: -.

# 2. Eligibility Conditions:

- I. Employees who have retired from government service on attaining the age of superannuation and below the age of 65-years having good service records and are physically fit shall be eligible to be considered for re-employment.
- II. Employees against whom Departmental Proceedings or Criminal Cases are contemplated /pending or who have been penalized for misconduct during the period of preceding five years shall not be eligible for consideration.

## 3. <u>Selection Process</u> :

Selection will be made through the Selection Committee constituted for the purpose.

# 4. Tenure, Term and Conditions:

- I. The re-engagement shall be made initially for a period of one year only.
- II. Re-engaged employees will be entitled to get monthly consolidated remuneration as per Para 2 of FDOM No.24533/F dated 29.09.2022.
- III. Re-engaged employees shall be governed by the provisions of Odisha Government Servants Conduct Rules-1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions under the Odisha Pension Rules-1992.
- IV. The re-engagement can be terminated at any time by the Appointing Authority due to unsatisfactory performance of any of the re-employed employee by giving one month notice. On the contrary, if any re-employed employee desires to resign, he shall do so by giving one month's written notice to the competent authority.
